### GREETINGS:

In the name of the Commonwealth of Massachusetts you are directed to notify and warn the inhabitants of the Town of Dighton qualified to vote in elections and Town Affairs to meet in the Dighton Town Hall, at 979 Somerset Avenue, on Wednesday the twenty-seventh day of May 2015, 6:30 o'clock P.M., then and there to act on the following articles, viz:

ARTICLE 1. To hear the reports of the Town Officials and act thereon.

ARTICLE 2. To see if the Town will vote to rescind \$65,000 of the original \$200,000.00 authorization to borrow, voted under Article 17 of the Warrant for the Annual Town Meeting of May 21, 2001, or act thereon.

ARTICLE 3. To see if the Town will vote to transfer from free cash available in the Treasury \$100,000.00 to fund any obligation of the new Police Station/Communications Center project through June 30, 2015, or act thereon.
