Review/Discuss/Act: 2nd Reading of Outdoor Wood Burning Boilers Regulation

The Board proposes to adopt an Outdoor Wood Burning Boiler Regulation to protect the public health, comfort, and convenience from uncontrolled emissions of smoke and noxious fumes under the authority of Massachusetts General Law Chapter 111, Sections 31, 31C, and 122 and 210 CMR 11.02. The Board read the Regulation in its entirety (Attachment A) as the second reading. The Board will read the Regulation on October 9th and October 23rd before it goes into effect.
