Richard Bleau, President of the John Vangyzen Hall, Inc. appeared before the Board announcing that the Hall is officially closing effective immediately due to monetary reasons. The Board regretfully accepted Mr. Bleau's letter surrendering the lease and terminating as a tenant of the Vangyzen (former VFW) Hall at 495 School Street, North Dighton.
