
- Article 1: To choose a Moderator.

- Article 5: To see if the district will act on any other business that may lawfully be brought up before this meeting.



And you are directed to serve this Warrant by posting up attested copies thereof at two or more public places in various sections of the District seven days at least before the day and time set for said meeting.

Hereof fail not and make due return of this Warrant with your doings thereon to the District Clerk at the time and place of holding said meeting.


