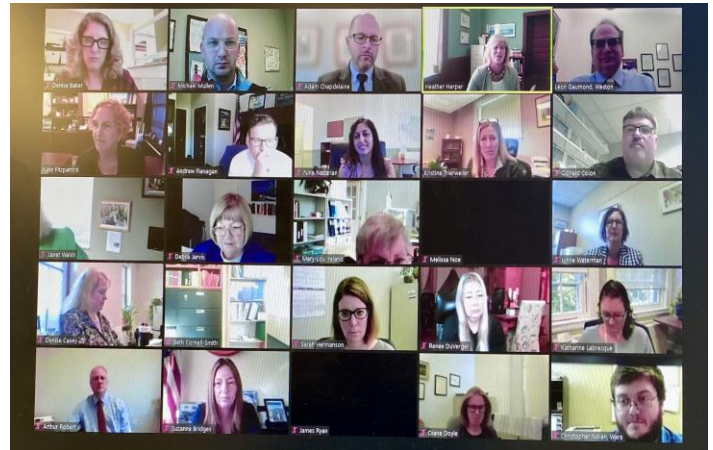
Hello, Dighton!

Community. That's the word that always comes to mind as I reflect on our work together during the last 8 months.

As I sit down to begin writing this month's newsletter, we are dealing with the aftermath of this week's Autumn Nor'easter. Our Fire, Police, Highway and Communications Departments have been working tirelessly to respond to storm emergencies and downed trees and wires in numerous areas of town.

I think about the leadership and coordination between Fire Chief Chris Maguy, Police Chief Bob MacDonald, Highway Superintendent Tom Ferry, our first responders, dispatchers, and Highway Department staff to make these efforts possible. I think about the countless calls to dispatch and the professionalism and care in their response. I think about the phone calls and emails from residents seeking their assistance. I'm also reminded of our priority throughout the storm and up until now to share information with residents via email and social media to provide updates on power outages, road closures, and anticipated power restoration efforts.

This month I had the chance to participate in the Massachusetts Municipal Management Association's annual 'Boot Camp' for municipal managers, assistant municipal managers and aspiring municipal managers across the state. This year's 'Boot Camp' was held via Zoom and focused on what I call the 'nuts and bolts' of local government: budget and capital planning, financial forecasting, and outreach and communications.

Community Electricity Aggregation Update Provided to Board of Selectmen

Dighton's Community Electricity Aggregation (CEA) program is providing a great monetary benefit to town residents. That was the report presented to the Board of Selectmen and Dighton residents during the Board's October 13, 2021 meeting.

Now in its 5th year since being launched in January 2016, Dighton's CEA has saved the Town and its residents a cumulative total of \$838,033 in electricity costs in all rate classes.

These savings are expected to increase significantly with National Grid's Basic Service Residential rates increasing to \$.014821/hWh on November 1st when compared to Dighton's CEA Standard rate costs of \$.010470/kWh, locked in through December 2023.

The Dighton CEA program recently sent a Customer Notification Letter to new electricity customers in Dighton.
