

BOARD OF SEWER COMMISSIONS – MINUTES 2019
April 22, 2019

Meeting opened at 4:30 P.M.

Present: Carol Beauregard, Thomas Ferry, Supt. Harold Gracia and Dianne Curtis. Paul Joly was not in attendance.

Review and sign bills.

Payroll was signed singularly by Carol Beauregard singularly on 4/16/19 and 4/22/19.

Minutes: Minutes of April 8th were approved.

New Business:

Discussion Regarding a Sewer Stub on 1400 Somerset Avenue: The Board and Supt. Harold Gracia reviewed plans for 1400 Somerset Avenue to see if a Sewer Stub is at 1400 Somerset Avenue. Supt. Gracia indicated that there was a Gravity Sewer Stub at this location.

Sewer Connection Permit for 528 Old Somerset Avenue: The Board reviewed a Sewer Connection Permit for 528 Old Somerset Avenue. Thomas Ferry motioned to accept the Sewer Connection Permit for 528 Old Somerset Avenue; Carol Beauregard stepped down as Chair and seconded the motion; all ayes; none opposed; motion passes.

Drain-Layer Permit Application from Vesta Development Corp.: The Board reviewed an application for Vesta Development Corp. to become a Licensed Drain-Layer for the Town of Dighton. Thomas Ferry motioned to accept Vesta Development Corp. to become a Licensed Drain-Layer; Carol Beauregard stepped down as Chair and seconded the motion; all ayes; none opposed; motion passes.

Discussion Re: Pump Station Values: There was discussion regarding the values of the Pump Stations (building and machinery/equipment) for Insurance coverage purposes. Chairwoman Carol Beauregard stated to request an inquiry of assessments of the pump stations and equipment from the Insurance Company.

Question Re: Sewer Availability on Lou Lane: Chairwoman Carol Beauregard stated she received a phone call of general inquiry of sewer availability on this street. The Board and Supt. Harold Gracia reviewed plans for sewer availability on Lou Lane.

Old Business:

None at this time.

Superintendent's Report:

Supt. Harold Gracia stated that the Town Electrician, Paul St. George from PFS Electric, wired the second pump at the Bristol County Agricultural High School Pump Station.

There was discussion regarding New England Safety Systems (N.E.S.S.) completed the alarm issues at the Lincoln Avenue and Park Street Pump Stations.

Supt. Gracia stated that Delta Electric pulled the pump at the Route 138 Pump Station.

Supt. Gracia stated that he and a representative from Samiotes Consultants, the Engineer for the B.C.A.H.S. Expansion Project, were at the Pump Station to verify the size of the forced main.

Supt. Gracia stated that a low-level alarm went off at the Power Plant Pump Station. He also stated that the backup engine kicked out because the fuse blew out and he was there pumping out the wet well. He stated that he contacted Ralco Electric to troubleshoot the issues with the control panel.

Thomas Ferry motioned to adjourn at 6:00 P.M.; Carol Beauregard stepped down as Chair and seconded; all ayes. Meeting adjourned.
