2. TO APPLY FOR A SEWER CONNECTION PERMIT THE FOLLOWING ITEMS MUST BE FOLLOWED:

A. APPLICATION MUST BE FILLED OUT PROPERLY AND THE PERMIT FEE PAID WHEN SUBMITTED

B. AN 8 ½ X 11 PLAN DRAWING OF THE PROPOSED WORK MUST BE SUBMITTED BY THE DRAINLAYER AND ATTACHED TO THE PERMIT APPLICATION. THE DRAWING WILL HAVE THE APPLICANT'S NAME AND ADDRESS; LOCATION OF HOUSE AND HOUSE NUMBER; DISTANCE OF HOUSE TO THE STREET; LOCATION OF THE STREET STUB; AND THE PROPOSED WORK – WITH DISTANCES AND LOCATIONS OF PIPE, CLEANOUTS; INSPECTION AND RISER TEE LOCATION AND OTHER NECESSARY PROPOSED WORK SHOULD BE LISTED. **ALL UTILITIES MUST BE LOCATED ON THE PLAN.** \*\*\*\*\*IN ADDITION, CEASPOOLS AND SEPTIC SYSTEMS MUST BE PROPERLY ABANDONED, RECORDS SUPPLIED TO THE SEWER DEPARTMENT AND THE DIGHTON BOARD OF HEALTH MUST BE CONTACTED PRIOR TO THE ABANDONMENT OF THE SYSTEM.

– C. A CURRENT COPY OF THE DRAINLAYER'S INSURANCE MUST BE ON FILE.

D. AN AS BUILT PLAN MUST BE SUBMITTED BY THE DRAINLAYER OR PLUMBER WITHIN 30 DAYS OF THE JOB COMPLETION. FAILURE TO DO SO COULD RESULT IN THE LOSS OF THE DRAINLAYER'S LICENSE.

3. IN CONSIDERATION OF GRANTING THIS PERMIT, THE UNDERSIGNED AGREES TO ACCEPT AND TO ABIDE BY THE PROVISIONS OF THE DIGHTON SEWER USE BY-LAW AND ALL OTHER PERTINENT ORDINANCES AND OR REGULATIONS THAT MAYBE ADOPTED IN THE FUTURE. FURTHER, THE UNDERSIGNED AGREES TO MAINTAIN THE BUILDING SEWER AT NO EXPENSE TO THE TOWN.

**THE SEWER SUPERINTENDENT MUST BE NOTIFIED 48 HOURS IN ADVANCE, BEFORE ANY PORTION OF THE WORK IS BACKFILLED, FOR THE INSPECTION AND CONNECTION TO THE PUBLIC SEWER. SOMEONE MUST BE AVAILABLE AT THE INSPECTION SO THE INSIDE WATER METER CAN BE READ. IF ACCESS CANNOT BE GAINED, THE LAST KNOWN WATER READING WILL BE USED TO CALCULATE THE SEWER BILL.**
