

Dighton Board of Health Schedule of Fees

Under the authority of Massachusetts General Laws, Chapter 111, Section 31 and all other statutes enabling Boards of Health to set fees for licenses, permits and services, the Dighton Board of Health hereby adopts and promulgates the following fee structure on June 12, 2019 at its regularly scheduled meeting. All fees shall become effective July 1, 2019.
