### **Secretary's Report**

### **Community Preservation Committee Report**

- CPC will support application and request for \$25,000 to hire preservation consultant and FY2021 Survey Planning Grant. The vote was unanimous. Thank you to Dighton CPC.
- Ms. Gales compiled Annual Report for Dighton Historical Commission. Motion to approve by Ms. Nickerson. Seconded by Ms. Olsen. All in favor.

### **Unfinished Business**

#### ***1. Boston Post Cane***

- Ms. Olsen sent letter to Mrs. Veronique Mbongue: our next possible recipient. No response. Mr. Joseph Welch will potentially be the next candidate.
- Family of the late Maria Barboza is available for ceremony.
- A glass case will be moved from Bristol Agricultural High School to Old Town Hall. Artifacts may be changed biannually. Ms. Olsen suggests incorporating milk bottles.
- Ms. Gales plans a cooperative effort with the Historical Society; their items will be stipulated "on loan."

#### ***1. Survey and Planning Grant FY21 Application***

- Project coordinators will meet, including Ms. Gales and Mr. Michael Mullen, Town Administrator.

## **Review of Demolition Bylaw**

- Notification, prior to demolition of a 100-year-old building, or older, will be sent to Dighton Historical Commission.
- Chair of Historical Commission must request information, for Historical Commission business, involving Board of Selectmen. Requests for personal use are permissible.
- A six-month delay allows Historical Commission to be responsible to offer alternatives, and resources, to homeowners.
- Discussion should remain respectful.
- Demolition bylaws are consistent across Massachusetts' cities and towns; wording echoes one another.
- Mr. Pruitt questions method of determining "historic" homes.
- Events and associations of people of interest, also social status and architecture may determine significance.

## **Other:**

- Two vacancies remain on Historical Commission.
- Anderson Medal of Honor Ceremony, March 30, 2021 was wonderful, well-planned, dignified.
- Board of Selectmen is addressing vacancies on all commissions.
