Preservation Planning

1. FY 21 Survey and Planning Grant Status
- Mullen, Delfin and Gailes, via Zoom, on May 26, received instruction and templates. The contract is between Dighton Board of Selectmen and Massachusetts Historical Commission.

- Requests for quotes from consultants will be complete by July 12, 2021 and due August 11, 2021. The selection committee includes DHC, Myrna Santos and Mullen (non-voting.) Criteria and rubric will be specific.
 - Approximately 100 properties will be surveyed for MACRIS; information will be available digital and print.
2. Historical House Marker Program
 - Delfin will draft a letter for homeowners regarding National Historic Register.
 3. Repurposed wood from Briggs house
 - Building Commission, James Aguiar suggests repurposing boards, as flooring, in the town clerks area. A plaque will explain origination of materials.
 - Pruitt states that New York and Boston have lost buildings; these cities published books with photos and inscriptions. Pruitt would like a photo of Briggs home incorporated on the plaque.
 - Olsen makes a motion to perhaps locate a photo on Zillow; assist with design/pricing on plaque; seconded by Nickerson. All in favor.
 - Pruitt will have a short write-up on James Briggs genealogy to read at our July meeting.

- Preservation Massachusetts will hold virtual conferences September 23 & 24, 2021; info to follow.

- Dighton Historical Society is sponsoring Graveyard Girls on September 9, 2021 at 6PM. Olsen attended a prior tour, which explained symbolism of headstones.
- Olsen asks what information is available of Myrna Santos' recent cemetery tours.
