1. Boston Post Cane

- Ms. Nickerson makes a motion to contact Mr. Joseph Welch; seconded by Ms. Olsen. All in favor. Ms. Gales will contact Mr. William Welch, son.
- The display case, donated by Bristol County Agricultural High School, will hold Boston Post Cane and Anderson Medals. Dighton Historical Society may provide items "on loan."
- Ms. Nickerson feels the Historical Commission lacks specifics of the case; she offered to view the case.
- Family of the late Mrs. Maria Barboza is available for ceremony in June.

2. Community Garden plaque/marker

- Ms. Nickerson, Ms. Gales & Mr. Delfin will research plaques and signs.
- Ms. Nickerson noted the implied belief is 949 Somerset Avenue will be the future site of the library; the layout places garden beds East.

- ### *2. Discuss/act on initial notification of demolition of 593 Williams Street*
- The 100 + year old property suffered tree damage; the owner wishes to demolish; utilities are disconnected. 593 Williams Street does not appear on MACRIS, nor an 1871 town map.
 - 593 Williams Street might have been part of the Charles Marble Dairy Farm, which operated from 1880-1942; Ms. Olsen states that land has been sold off. Ms. Olsen says she will not invoke the 6-month delay.
 - Ms. Nickerson makes a motion that 593 Williams Street does not have historical significance, based on research, and is not subject to a 6-month delay bylaw; seconded by Ms. Olsen. All in favor.
 - Ms. Gales will send a letter to Building Commissioner, James Aguiar of the DHC vote regarding 593 Williams Street.
