

ANNUAL TOWN MEETING

MAY 21, 2001

The Annual Town Meeting, held on May 21, 2001 at the Dighton-Rehoboth Regional High School, was called to order at 7:06 PM by William E. McKeon, Jr., Moderator. Salute to the flag was given. Checkers were Joan Ready and Alice Souza. Total attendance was 164.

VOTED: On motion of Frank Costa to dispense with the reading of the Warrant.

VOTED: On motion of Frank Costa to dispense with the reading of the Articles and reference to them be made by number and content.

VOTED: On motion of Frank Costa to consider adjournment at 11:00 P. M.

ARTICLE 1. VOTED: On motion of Frank Costa to hear a report of the Board of Selectmen, Finance Committee and a statement of the Board of Assessors, and the School Committee regarding tonight's warrant and that the reports of the Town Officials as printed and published in the Annual Town Report Book be accepted.

For the Board of Selectmen, Gene Nelson asked for a moment of silence for all residents who passed away during the past year. He asked voters to support the budget proposals and the article regarding the sale of two town-owned properties. He thanked all the appointed and elected officials and the Finance Committee for their services.

Peter Caron, Finance Committee Chairman, pointed out the change in the printed format of the departmental budgets in the Warrant. He stated that by not printing every budget line item, the town saved on warrant printing costs and by voting separately on personnel services and Expenses, department heads would have greater flexibility within their budgets. He explained that the Finance Committee's duty is to determine a balanced budget and that if voters did not support their proposals, the town would be in danger of exceeding the levy limit.

David Long, for the Board of Assessors, stated that the budget presented would result in an increase to the tax rate of \$1.58. He explained that of that figure, \$1.23 is the result of the addition to the Dighton Elementary School and the construction of the Middle School. He stated that he does not support using Stabilization funds to lower the tax rate.

Superintendent Dr. Connor, speaking on behalf of the School Department, urged voters to support the increase of \$725,000.

ARTICLE 13. VOTED: On motion of Alice Souza that the Town vote to establish a revolving fund into which shall be paid all fees, gifts, and donations received by the Dighton Council on Aging for services rendered by "PRIME TIME" (Adult Supportive Day Care). Said fees to be expended from said revolving account by the Council on Aging Board for the purpose of providing for salaries, office supplies, equipment repairs and maintenance, and any other related expense, or take any action thereon. Spending shall be capped at \$60,684.29.

ARTICLE 14. VOTED: On motion of Gene Nelson that the Town vote to appropriate from available funds \$70,073.19 from the Massachusetts Department of Public Works for the purpose of expending funds for capital improvements on local roads under the "Transportation Bond Issue".

ARTICLE 15. VOTED: On motion of Lynn Dupont that the Town vote to re-establish a revolving fund into which shall be paid all overdue fines and monies collected by the Dighton Public Library for overdues, lost and/or destroyed materials; said monies to be expended from said revolving account by the Trustees of the Public Library for the replacement of lost and/or destroyed materials or take any action thereon. Spending shall be capped at \$5,000.00.

ARTICLE 16. VOTED: On motion of David Long that the Town vote to re-establish a revolving fund for the Dighton Planning Board into which shall be paid all money collected through the sale of subdivision rules and regulation's, zoning by-law booklets and zoning maps. In addition, all fees submitted to the Planning Board accompanied with Form A's, Preliminary Plans, and Definitive Plans filed in accordance with the M.G. L. Ch. 41, and the Town of Dighton Sub-Division Rules & Regulations. Said monies to be expended from said revolving fund by the Dighton Planning Board for the advertising and certified mailings of public hearing notices, engineers' fees, attorney's fees, amendment changes, zoning changes, long and short term planning purposes and related research, with a cap of \$30,000.00 (thirty thousand dollars).

ARTICLE 17. VOTED: On motion of Frank Costa that the Town vote to appropriate \$200,000.00 for the purpose of financing the following water pollution abatement facility projects: repair, replacement and/or upgrade of septic systems, pursuant to agreements with the Board of Health and residential property owners, including without limitation all costs thereof as defined in S. 1 of Ch. 29C of the General Laws; that to meet this appropriation the Treasurer with the approval of the Board of Selectmen is authorized to borrow \$200,000.00 and issue bonds or notes therefor under G.L.Ch. 111, S.127B ½ and/or Ch. 29C of the General laws; that project and financing costs shall be repaid by the property owners, in accordance with those agreements, but such bonds or notes shall be general obligations of the Town; that the Treasurer with the approval of the Board of Selectmen is authorized to borrow all or a portion of such amount from the Massachusetts Water Pollution Abatement Trust established pursuant to Ch. 29C and in connection therewith to enter in a loan agreement and/or security agreement with the Trust and otherwise contract with the Trust and the Department of Environmental Protection with respect to such loan and for any federal or state aid available for the projects or for the financing thereof; and that the Board of Selectmen, Board of Public Works or other appropriate local body or officials is authorized to enter into a project regulatory agreement with the Department of Environmental Protection, to expend all funds available for the projects and to take any other action necessary to carry out the projects.

ARTICLE 18. VOTED: On motion of Gene Nelson that the town vote to repay up to Seven Thousand Five Hundred (\$7,500) dollars during FY 02 to the Massachusetts Water Pollution Abatement Trust for the Title V Septic Loan Program. Funds to be taken from loan repayments made to the town from town residents that received Septic Loan Program Funds (Account 24-330-510-3300-309-40).

ARTICLE 19. DEFEATED: On motion of Gene Nelson that the town vote to change the Zoning Map of the Town of Dighton, as amended June 17, 1998, as follows: A petition was received from 107 registered voters from the Town of Dighton and certified by the Town Clerk. Under M.G.L.Ch. 40A S. 5, the Board of Selectmen reviewed and referred the petition to the Dighton Planning Board on December 6, 2000 so a public hearing could be held. On February 7, 2001 a public hearing was held to gather input from interested parties on the following proposed changes:

1. That the zoning district on Cedar Street from Williams Street to the Dighton town line be changed from business to residential for a depth of 400 feet on both sides of the roadway except for land owned by the Dighton Water District.
2. That the zoning district on Lewis Street from Cedar Street to the Dighton town line be changed from business to residential for a depth of 400 feet on both sides of the roadway.
3. That the zoning district on Smith Street northerly from Cedar Street for a distance of 2,500 feet, for a depth of 400 feet on the westerly side, and depth of 1,000 feet on the easterly side, be changed from business to residential.

After review by the Dighton Planning Board, a vote was taken, the results as follows: 0 votes in favor of the petition, 3 votes against the petition, 1 vote to abstain.
The Dighton Planning Board therefore disapproves any change to the Dighton Zoning Map at this time.

ARTICLE 21. VOTED: On motion of Lynn Dupont that the town vote to continue a revolving fund into which shall be paid all fees collected by the Dighton Public Library for copying and printing services, said monies to be expended from said revolving account by the Trustees of the Public Library for supplies or take any action thereon. Spending shall be capped at \$5,000.00

ARTICLE 22. VOTED: On motion of Gene Nelson that the Town vote to allow the Board of Selectmen pursuant to the provisions of M.G.L. Ch. 30B, the Uniform Procurement Act, to sell two parcels currently owned by the Town. The properties are as follows: a parcel located on Spring Street, Map 4, Lot 470 containing 321 square feet, more or less, and a parcel located on Somerset Avenue, Map 5, Lot 96 containing 1.81 acres, more or less.

VOTED: On motion of Frank Costa that the Town vote to authorize the Board of Selectmen to accept and enter into contract for the expenditure of any funds allotted or to be allotted by the Commonwealth and/or Federally-aided programs for the construction, reconstruction and improvements of Town roads.
